

**REGULATIONS PURSUANT TO ARTICLE 11 OF PRESIDENTIAL DECREE NO. 430 OF 26  
OCTOBER 2001  
PRIZE CONTEST  
"STRADE BIANCHE PLAY & PREDICT"  
(CL 36/2026)**

**PROMOTING ENTITY**

RCS Sport S.p.A with registered office at Via Rizzoli 8 – 20132 Milan, Italy (hereinafter, the "Promoter").

**DELEGATED COMPANY**

Clipper S.r.l., Via Caterina da Forlì 32, 20126 Milan, Italy (hereinafter, the "Delegate").

**CONTEST NAME**

"STRADE BIANCHE PLAY & PREDICT" (hereinafter, the "Contest").

**TERRITORY**

The Contest is conducted via the website <https://www.giroditalia.it/fanzone/> (hereinafter, the "Website").

It is specified that the data of Participants taking part in the prize draw are stored on servers located in Italy. Specifically, the Contest management server is cloud-based, and Participants' data will be replicated on a dedicated server located in Italy. Consequently, for the purposes of prize draws, reference shall be made exclusively to the data recorded on the server located in Italy. The Promoter undertakes to provide the Public Authorities, upon simple request (including through the Delegate), with the Contest database. The Promoter does not carry out Internet Service Provider activities and derives no economic profit from the internet connection. Connection costs depend exclusively on each Participant's personal tariff plan.

**DURATION**

The Contest runs from 7 February 2026 until 11:59:59 p.m. on 8 March 2026 (hereinafter, the "Duration").

The prize draw will take place by 15 April 2026.

**ELIGIBILITY**

The Contest is open to all users who are of legal age at the time of participation and resident in a Member State of the European Union\*, Albania, Iceland, Norway, Liechtenstein, the United Kingdom (UK), Switzerland, and the Republic of San Marino (hereinafter, the "Participants").

Employees and collaborators of the Promoter, employees and collaborators of companies involved in the organization of the Contest, and any individuals who do not meet the definition of Participants are excluded.

## **ADVERTISING**

The Contest will be promoted on the Website, where these full regulations will be made available. The Promoter reserves the right to adopt additional advertising methods in compliance with Presidential Decree No. 430/2001 on prize promotions. All advertising communications will be consistent with these regulations.

## **MODALITIES OF PARTICIPATION**

The Promoter launches this Contest, which will take place according to the procedures described below.

Participation is available through the “FanZone” section of the Giro d’Italia website at <https://www.giroditalia.it/fanzone/>, accessible upon registration at <https://myaccount.giroditalia.it/> by completing the mandatory registration form or by logging in if already registered.

To complete registration, Participants must declare that they have read, understood, and accepted these Regulations.

During the Duration, in order to participate in the prize draw, Participants must access the Website and carry out one or more of the following activities:

- a) completion of a questionnaire;
- b) Strade Bianche Predictor: selection of three male athletes expected to place in the top three positions;
- c) Strade Bianche Women Elite Predictor: selection of three female athletes expected to place in the top three positions.

Participants may choose to take part in all activities or only one or more of them.

### **a) Questionnaire**

During the Duration, Participants must complete a questionnaire consisting of five (5) multiple-choice questions randomly selected from a predefined database. Only one answer per question is correct.

Participants may answer the questions only once, consecutively, within a time limit, with no possibility of modifying submitted answers.

Upon completion, the Participant will be entered once into the draw file. If all five answers are correct, the Participant will be entered an additional time.

Participation is valid from 7 February 2026 until 11:59:59 p.m. on 8 March 2026. Entries submitted after this period will not be considered.

### **b) Strade Bianche Predictor**

Participation is permitted exclusively on 7 March 2026.

On that date, Participants must select three (3) distinct male athletes, from among those officially registered for the race, who they believe will finish in the top three positions of the 2026 Strade Bianche.

The order of finish is irrelevant. Participation is valid only if three distinct athletes are selected.

Each Participant may submit only one prediction, exclusively between 8:30 a.m. and 12:30 p.m. (CET). Entries outside this time window are invalid.

Each valid Participant will be entered once into the final draw file, regardless of whether the prediction is correct.

The Promoter shall not be liable for technical issues, website malfunctions, or connectivity problems beyond its control.

### **c) Strade Bianche Women Elite Predictor**

Participation in the Strade Bianche Women Elite Predictor shall be permitted exclusively on 7 March 2026. On that date, Participants shall, within the relevant dedicated section and in accordance with the instructions provided therein, select from among all female athletes officially registered for and competing in the race three (3) distinct athletes who, in the Participant's assessment, will place in the top three positions of the 2026 Strade Bianche.

Participation shall be deemed valid solely where three (3) distinct athletes are selected.

Participants shall indicate the three athletes they believe will finish in the top three positions of the race, without the need to specify the order of arrival, which shall in no way be relevant for the purposes of participation.

Any failure to make a selection, or any incomplete or non-compliant selection, shall result in the invalidity of the participation.

Each Participant may make the selection only once, exclusively on 7 March 2026, within the time window from 8:30 a.m. to 12:30 p.m. (CET). Participations submitted outside the aforementioned time window shall not be considered valid.

The Promoter shall not be held liable for any technical issues, website malfunctions, interruptions of connectivity, or other causes not attributable to the Promoter that may prevent or limit participation in this activity.

Each Participant shall be entered once only in the file used for the purposes of the final draw, provided that the prediction has been submitted in accordance with the provisions set out above, irrespective of whether the prediction proves to be correct.

At the end of the Contest, a file containing all participations received during the Duration shall be prepared. Each Participant shall be included in the file for the final draw according to the number of valid participations accrued, in accordance with the provisions of these Regulations.

### **FINAL DRAW**

By 15 April 2026, in Milan, at the offices of the Delegate or at another location to be agreed upon, and in the presence of a Notary Public or an official of the competent local Chamber of Commerce, the final draw provided for herein shall be conducted. The Promoter shall provide a file containing all participations duly received and, where applicable, repeated in accordance with these Regulations, from which one (1) winner, who shall be awarded the prize at stake, and ten (10) reserve winners, who shall take over in the event of the original winner's unavailability or irregularity, shall be drawn. The Promoter shall verify compliance with the participation requirements, in particular confirming that the winner has complied with these Regulations, failing which the winner shall be disqualified and replaced by a reserve.

### **WINNER NOTIFICATION**

The winner shall be personally notified in the days following the draw by means of an email communication. The winner shall be required to submit, in accordance with the procedures and within the deadlines indicated in the winning notification, complete personal identification details (first name, last name, full address, date of birth, telephone number), and may also be required to provide a copy of a valid identity document. The prize shall be definitively awarded only upon completion of the necessary checks regarding the regularity of the documentation submitted, in

compliance with these Regulations, and verification of the consistency between the personal data provided at the time of registration and the personal data shown on the identity document, where requested. Upon confirmation of the win, the winner shall receive all information necessary for the enjoyment and use of the prize. Failure by the winner to respond within the deadline indicated in the winning notification, or failure to provide the identity document where requested, shall result in the forfeiture of the prize, which shall be awarded to the first eligible reserve, who shall be required to respond in accordance with the same procedures and deadlines.

The Promoter shall not be liable in relation to any winner where:

- the Participant has not provided a valid and functioning email address at the time of account registration;
- the Participant fails to check their email inbox in a timely manner and within the final deadline for validating the win;
- the email inbox is full or has insufficient storage capacity;
- the email address provided during registration is incorrect, incomplete, or non-existent;
- no response is received from the host server following the sending of the winning notification email;
- the email inbox is disabled;
- the email address provided has been placed on a blacklist, deactivated, or is otherwise non-functioning;
- the notification email is filtered as spam and/or is not read.

## **PRIZE**

The winner shall be awarded one (1) Colnago V5Rs bicycle, equipped with a Shimano Ultegra Di2 groupset and Vision SC45 wheels, size Colnago 510, with a total value of **€10,800 (VAT included at 22%)**.

*The V5Rs is Colnago's flagship racing frame designed for competitive use. The bicycle features a monocoque frame offering excellent performance in terms of stiffness-to-weight ratio and aerodynamic efficiency. The same frame was used by Team UAE Emirates during the 2025 season to achieve a record number of professional victories in a single season. The prize model is fitted with a Shimano Ultegra Di2 12-speed electronic groupset, Vision SC45 carbon wheels, and an integrated Colnago CC.01 carbon handlebar.*

## **PRIZE POOL**

The total value of the prize pool amounts to **€10,800 (VAT included at 22%)**.

With respect to such amount, the Promoter provides the legally required guarantee in favor of the Ministry of Enterprises and Made in Italy, pursuant to Presidential Decree No. 430/2001.

## **WAIVER OF THE RIGHT OF RECOURSE**

The Promoter hereby declares that it waives its right of recourse in relation to the withholding tax at source in favor of the winners, pursuant to Article 30 of Presidential Decree No. 600/1973.

## **FULFILMENTS AND GENERAL PROVISIONS**

All operations shall be carried out in accordance with the laws and regulations in force in Italy. The prize awarded shall be delivered to the winner within 180 days from the date of the official draw report. The prize shall be shipped by courier. The Promoter shall not be liable for any failure to deliver the prize due to an incorrect address provided by the winner or the winner's repeated absence.

The Promoter assumes no liability for any damage of any nature or extent to property or persons arising from the use of the prize once delivered and accepted; in all cases, the manufacturer's instructions and warnings shall apply. Any defects and/or malfunctions of the prize shall be governed exclusively by the manufacturer's warranty and assistance terms. The Promoter shall

under no circumstances be held liable for any issues arising during the use of the prize or for any improper use of the prize by the winner. By participating in the Contest, Participants indemnify and hold the Promoter harmless from any issues, damages, and/or injuries to property and/or persons arising from the use of the prize.

In the event of subsequent unavailability, the Promoter reserves the right to replace the prize with one of a similar nature and necessarily of equal or greater value. The Promoter also reserves the right to replace the prize with a subsequent model, where available. The prize may not be replaced, transferred, or converted into cash, nor may the winner request, with or without the payment of additional sums, an alternative prize. Any ancillary costs necessary to enjoy or use the prize shall be borne by the winner.

Should the prize not be awarded or not be claimed, including by reserve winners, the Promoter undertakes to donate goods, products, or services of equivalent value to charity. By registering, Participants unconditionally accept the rules contained in these Regulations. Consumers who, at the sole discretion of the Promoter or third parties appointed by it to manage the prize contest, participate using means or tools deemed suspicious, fraudulent, or in violation of the proper conduct of the initiative shall not be entitled to any prize obtained in such manner. The Promoter, or the companies appointed by it to manage the initiative, reserves the right to take any action deemed appropriate, in compliance with applicable laws, to limit or prevent any attempts to circumvent proper participation.
